WHO WE ARE AND WHAT WE DO

The Kensington & Chelsea Foundation is an independent charity set up in 2008. Since then, we've worked to tackle the inequalities faced by many across the Borough which the recent Grenfell Tower tragedy brought into stark relief.

The levels of child poverty, variations in life expectancies, high unemployment and isolation are just some of the issues which, with your help, we are working to address.

WHY US?

We have a pulse on the community and the work of many local charities. By becoming a Friend or Patron, you will be playing your part to help positively change local lives. This year, as we celebrate our 10th Anniversary and in the wake of the terrible fire in North Kensington, our work across the Borough has never been needed more.

IMPACT

Since 2008, we have raised more than **£12 million** with **£5 million** of that invested to support over 150 local charities to improve the lives of local people. More recently, we played a central role in fundraising for the Grenfell Tower tragedy and our appeal raised **£7 million** to support the survivors, the bereaved and the wider affected community.
