WHAT IS THE **WINTER WARMTH** CAMPAIGN?

The **Winter Warmth** campaign runs during winter each year to help older people who are struggling to cope, and may be forced to choose between heating and eating.

We raise funds so that older people can be helped with their heating costs and keep warm.



You can make a big difference to those who face real hardship during the winter months by giving to the appeal. Here's how:

If you receive the Winter **Fuel Payment**, you can **donate all or part of it** to a neighbour in need.

If you are an individual, business or school, you can donate, or fundraise in a variety of ways and we would be happy to help you with suggestions.

Due to illness, Mr and Mrs W are unable to go out much. Their flat is in the basement and none of the windows have double glazing. They are often cold, but rarely turn on the heating because they are worried about money. Winter Warmth provided them with £400 to heat their home and be warm.
